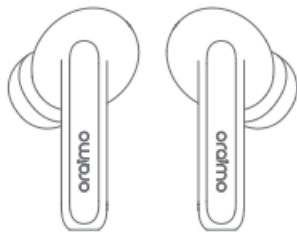

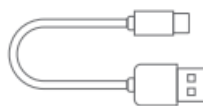

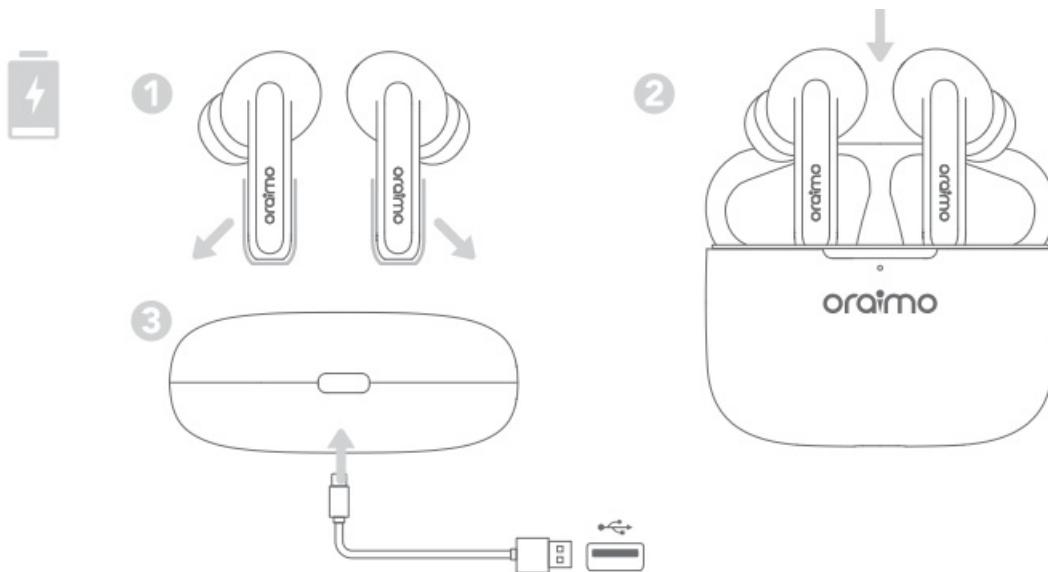

USING YOUR EARBUDS

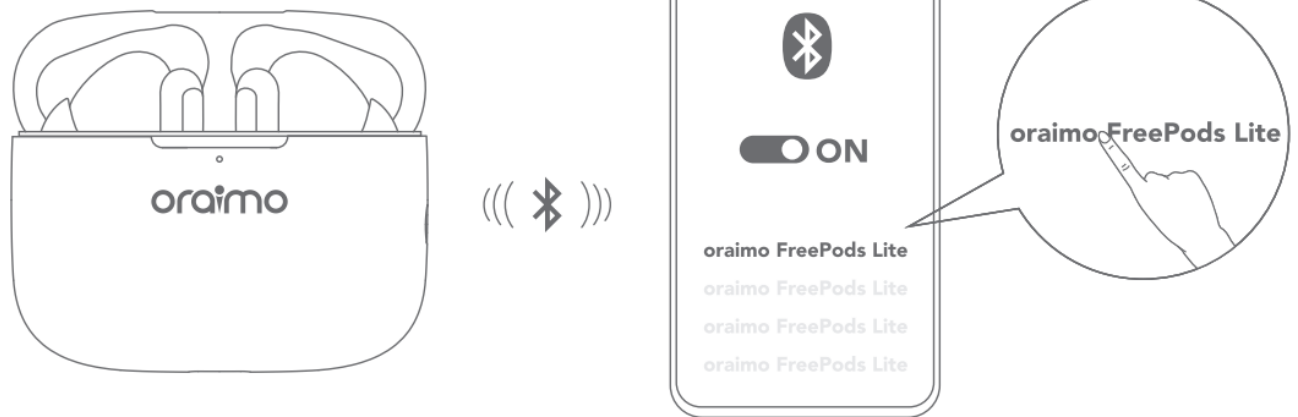
1.



Remove the protective film.

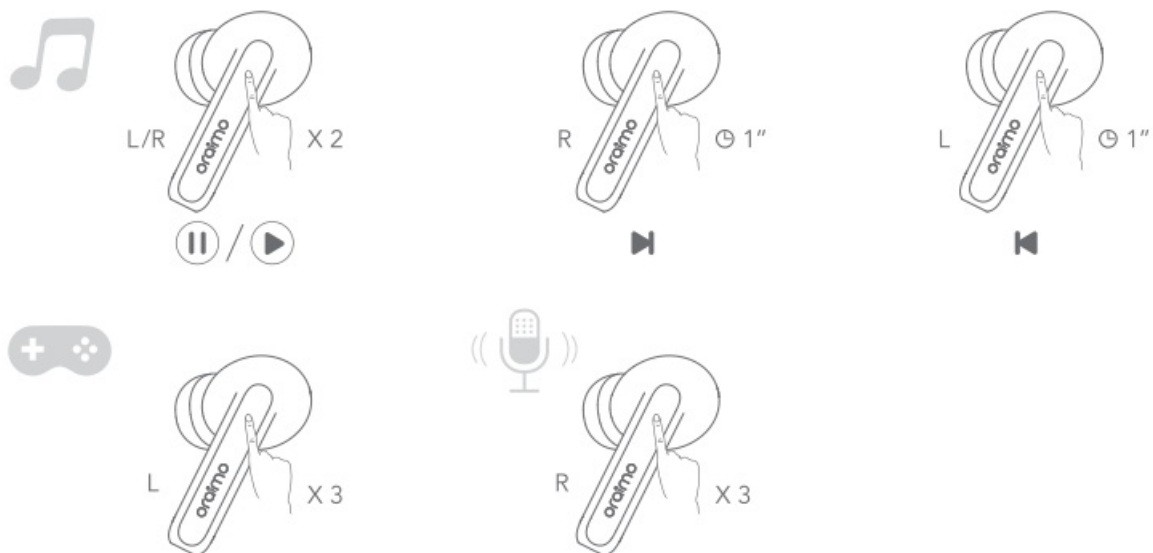
2. Put the earbuds back to the charging case.

3. Fully charge the case for 2 hours.



Earbuds will turn on and enter pairing mode automatically when open the lid of charging case for the first time use.

CONTROLS



- **Play/Pause:** Tap twice, Next song: Long press right earbud for 1 second, Previous song: Long press left earbud for 1 second Low-latency Mode (Game Mode); Tap left earbud for three times, Active voice assistant Tap right earbud for three times



1. **Answer/End a call:** Tap twice;
2. **Reject a call:** Long press one earbud for 1 second;
3. Three-way calling, When there is a new call coming during the call communication
 1. tap one earbud twice to hold the current call A and answer the coming call B, Long press one earbud for 1 second to switch call between A and B, Tap one earbud twice to end the current call.
 2. Long press one earbud for 1 second to reject the coming call B.

FAQ

Question 1	Reason	Solution
Earbuds don't turn off in the case.	Earbud charging contacts (pogo pin) may be dirty.	Use a cleaning cloth with alcohol to remove dirt from the pogo pin of earbuds.
Question 2	Reason	Solution
Only one earbud works.	There is no connection between the two earbuds.	<ol style="list-style-type: none">1. Put both earbuds back into the case with the lid open.2. Press the reset button on the case for 10 seconds until the indicator turns out.3. Close the case for 10 seconds to complete the reset.
Question 3	Reason	Solution
Left and right earbuds don't have the same sound level.	Ear wax may block the sound tube.	Remove ear wax gently with a brush or other cleaning tool.
